



GENERAL RULES FOR THE COMPETITION/LEISURE/ KARTING SPORTING ACTIVITY

STATEMENT

The undersigned, with the address in, born in with ID serial no, as user / attendant of the minor (representative by law of the minor) with the address in, phone number, e-mail

I declare on my own responsibility that I know the degree of danger and I assume my risk (or of the minor to whom I represent by law) to the karting activity and I shall use it in good conditions and as per karting instructions put at disposal by AMCKART.

I declare, also, that I agree AMCKART not to be responsible for unexpected material damages for which I am responsible for (or the minor to whom I represent by law) caused by bad usage of the kart or not respecting the presented general rules and instructions.

I shall respect all the AMCKART instructions and / or of its staff and I agree to repair the damage I cause to the kart, and/or other karts, owner's and / or third party's assets being guilty of not respecting the general rules, instructions or bad usage.

During my attendance (or of the minor to whom I represent by law) to the AMCKART events, my staying inside the AMCKART center shall be done in the access zones and in the special places made for audience.

I DECLARE THAT I KNOW AND UNDERSTOOD THE GENERAL RULES FOR THE COMPETITION/ LEISURE/ SPORT ACTIVITY PUT AT DISPOSAL BY AMCKART.

I DECLARE ON MY OWN RESPONSIBILITY THAT I DO NOT HAVE ANY DISEASE AND/OR INJURIES AND I AM NOT UNDER PILLS, DRUGS AND/OR ALCOHOL INFLUENCE.

I agree that my personal data to be used for the AMCKART data base, exclusively only for AMCKART.

For children under age of 14, attendant
(representative by law)

1. Participants in the completion/ sport activity must wear a protection helmet. The wearing of the cap given by AMCKART is obligatory in order to respect the hygiene rules. After the ending of the race the helmet, cap and any other equipment supplied by Amckart must be returned immediately.
2. The cloths must be tight on the body The wearing of the ties, scarves, belts etc. is not allowed if they are wore free.
3. Do not touch the engine or other warm parts if they are in running when you get in, out or during the kart running.
4. The access at the race start is allowed only to those persons who paid the race and agreed in writing the rules of the kart races.
5. The ticket no loses it validity if the owner is not present to the race start for which he has signed in.
6. If the rain starts, the race is stopped; the competitors have to reduce the speed and to go straight to the karts' start/finish zone.
7. The running is done only in the agreed direction (the racetrack has a left-handed sense).
- 8. IT IS FORBIDDEN TO BUMP OR TO CRAWL BY MEANS, TO GET OUT FROM THE SCENERY, THE DELIBERATE CUTS IN THE CURVES, THE DELIBERATE PARCKING ON THE RACE TRACK, AN AGGRESSIVE DRIVING BEHAVIOUR THAT CAN PUT INTO DANGER THE SAFETY OF THE OTHER COMPETITORS IS ALSO FORBIDDEN. IN THOSE CASES THE COMPETITOR IS TAKEN OUT FROM THE RACE WITHOUT BEING PAID BACK THE MONEY FOR THE RACE.**
- 9. IN CASE OF DAMAGE THE KARTS AND / OR OTHER PROPERTY OF THE OWNER AND THIRD PARTY'S ASSETS, ALL THE NECESSARY EXPENSES FOR REPAIRING AND REPLACING THE DAMAGED PARTS, WILL BE SUPPORTED BY THE GUILTY COMPETITORS.**
- 10. DECREASE SPEED BEFORE CURVES !**
- 11. DO NOT STEP THE ACCELARATION AND THE BRAKE SIMULTANEOUSLY !**
12. At getting out from the scenery, in case the kart stops, a damage appears or any other situation that requires stopping, the kart must not be left alone and assistance from the AMCKART personnel must be required by raising hands.
13. Participants in the completion/ sport activity must respect the AMCKART personnel's indications and signs; at the sign with a flag will be used as follows:
 - Chess Flag - indicates the finish of the race; the competitors will go straight to the start/finish zone using a decreased speed.
 - Blue Flag - you are being caught from behind from somebody else and you have to step aside in order for him to pass.
 - Yellow Flag - failure on the racetrack - the speed is reduced, no passes are allowed.
 - Red Flag - all the competitors must stop.
14. The using of the kart is forbidden after the race is over. Bringing the karts at the start zone will be done with a decreased speed.
15. Smoking and drinking alcohol on the racetrack is forbidden.
16. AMCKART is not responsible for the lost/forgotten objects inside the karting center.
